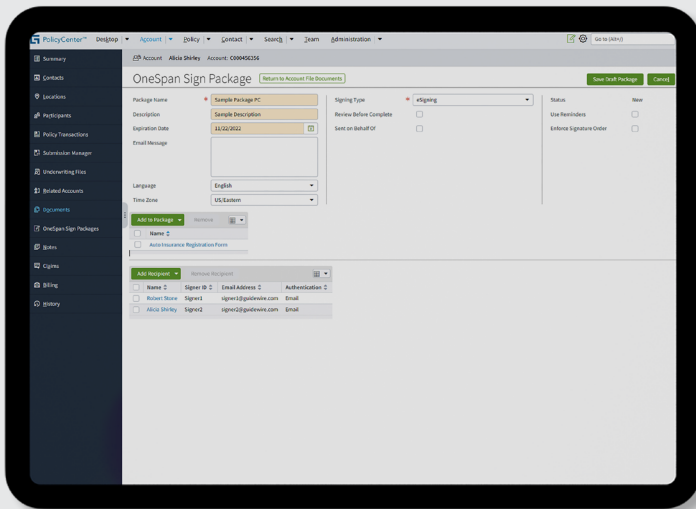

**3. Document Signing**  
After sending the document, your signers can e-sign the policy document anywhere, anytime, and on any device

**4. Archive**  
After signing is complete, e-signed documents with their audit trails are automatically stored in PolicyCenter
